AUP 001 Purpose

The Accessible Usage Policy (AUP) establishes guidelines for the responsible, ethical, and safe use of technology and digital resources within Queen Mira International School. The policy ensures that all stakeholders of the school community—students, staff, teachers, parents/guardians, and visitors—have equitable access to digital tools, while promoting responsible behaviour aligned with the school’s mission, values, and the CIS Code of Ethics.

AUP 002 Scope

This policy applies to:


- All students, teachers, staff, parents/guardians, and visitors.
- All school-owned devices, personal devices connected to the school network, and cloud-based services.
- All digital platforms used for academic, administrative, and co-curricular purposes.

AUP 003 Guiding Principles

1. **Equity & Inclusion** – All users should have fair and inclusive access to digital resources.
2. **Digital Citizenship** – Users must act responsibly, respectfully, and ethically online.
3. **Safety & Privacy** – Protecting personal information and ensuring online safety are top priorities.
4. **Academic Integrity** – Technology must be used to support authentic learning and respect intellectual property.
5. **Accountability** – Users are responsible for their actions when using technology.

AUP 004 Acceptable Use

Users are expected to:

- Use school devices, networks, and resources for educational purposes.
 - Respect others by using inclusive, non-discriminatory, and non-offensive language.
 - Maintain academic honesty when accessing, creating, or sharing digital content.
 - Protect their own and others’ privacy by safeguarding login credentials and personal data.
 - Report any inappropriate use, cyberbullying, or security breaches to staff.

AUP 005 Unacceptable Use

The following activities are strictly prohibited:

- Accessing, creating, or sharing harmful, violent, or inappropriate material.
- Cyberbullying, harassment, or discrimination in any form.
- Attempting to bypass security systems, hack, or damage school networks.
- Plagiarizing or violating copyright laws.
- Using devices during instructional time without permission.

AUP 006 Accessibility & Inclusion Commitments

- The school will provide assistive technologies and accessible platforms to support students with diverse learning needs.
- All digital resources will meet international accessibility standards wherever possible and applicable.
- Teachers will integrate digital literacy and accessibility practices into classroom learning.

AUP 007 Responsibilities

- **Students** – Follow AUP, practice digital citizenship, and report misuse.
- **Teachers & Staff** – Model responsible digital use, monitor student activity, and teach digital safety.
- **Parents/Guardians** – Support responsible technology use at home and partner with the school in promoting online safety.
- **School Leadership** – Ensure infrastructure, training, and monitoring are in place to uphold this policy.

AUP 008 Monitoring & Enforcement

- The school reserves the right to monitor digital activity on its networks.
- Violations may result in disciplinary action, ranging from warnings to restricted access, depending on severity.
- Repeated or severe breaches will be addressed under the school's disciplinary framework.

AUP 009 Review & Updates

This AUP will be reviewed annually by the Technology Integration Committee and aligned with CIS accreditation standards, legal regulations, and emerging best practices in digital education.

AUP 010 Acknowledgement

All students and staff must sign the Accessible Usage Agreement Form annually as a condition of access to school technology.

AUP 011 Accessible Usage Agreement Form

This form must be signed by students and parents/guardians each academic year as part of the school's commitment to safe, responsible, and accessible technology use.

AUP 012 Student Agreement

- Use school devices and networks for learning and positive purposes only.
- Respect others online and avoid cyberbullying, harassment, or inappropriate behavior.
- Protect my privacy and the privacy of others by keeping personal information safe.
- Not access, share, or create harmful or inappropriate content.
- Be honest and responsible when using digital tools (no plagiarism, hacking, or cheating).
- Report anything unsafe, suspicious, or harmful to a teacher or staff member.


